CHRONICLE, PURPOSES AND STRUCTURES OF THE EUROPEAN ACADEMY OF SCIENCES, ARTS AND LITERATURE.

Chronicle:

In 1973, during an International Congress, I suggested to the Kremlin Tribune, the creation of a European Academy which will consolidate the most important European intellectuals, Scientifics, writers and artists.

The 5th of May 1980, Mr. the Minister signed an Act, authorizing the creation of the European Academy of Sciences, Arts and Literature, for which the Head of office is based in Paris.

The founder's members in presence were The Professor Raymond Daudel, from the Sciences Academy of the France Institute, the Professor Renee Huyghe from French Academy, the writer Armand Lanoux Secretary of the Goncourt Academy.

Aims:

The European Academy Purposes are in their principles very similar from the ones of the UNESCO [according the Acts of the 16 of the November 1945.]

The Academy aims to encourage the partnership between all nations, on various levels such as Education, Sciences, Art and Literature with no distinction of race, sex, languages, religions or politic opinion.

At the times where the needs of high degree involve strong specialization leads to the fragmentation of knowledge, the Academy is a body of Intelligence able to contribute to large consolidation. Its target is based on the Analysis of the important issues that our society encounters which needs a multinational and multi subject. [Sciences, Human Sciences, Technology, Art and Literature]

The Academy is a nongovernmental International Organization which Acts on the side in partnership with other National and International Organizations.

Structures:

The Academy is divided essentially in four groups.

"The body" of the Members holders is formed of Persons chosen for their versatility, especially within the National Academies and within the Laureates of International Prices, such as the Nobel Price or Erasme Price.

350 members actually belong to this group which is part of 55 National Academies spread in the world. This body also counts 70 laureates of the Nobel Price.

The European Academy links the features of the National Academies of Sciences, Art and Literatures and encourages the relationship between creators and philosophers which rarely work together.

In principle, the Academy is considered as European; however the Academy has a worldwide status because it contents other delegations based on other continents such as Africa, America, Asia and Oceania.

It aims to help Europe to understand its role in the world and also to acknowledge the non Europeans countries.

The Committee of Honor is constituted of Personalities leading Nations, International Organizations, States leaders, Ministers, General Directors capable to attract the Attention of the Academies on important and practical issues.

The group of Correspondent Members is constituted of brilliant creators able to join the Commission of Experts created to investigate the problems that the Academy will have to look upon.

The Committee of Patronage is constituted of persons wishing to support the work carry out by our company.

From 1980 to 2003, the European Academy was chaired by the professor Raymond Daudel, Member of the Institute of France and numerous academies in the world and since 2003m by the professor Guy de The, important biologist of the Institute of France and The Pasteur Institute.

Activities:

Since 1980, The European Academy has reflected on various questions.

Such as examples, for five years, we have organized international conferences based on the theme "Society and Innovation" in different European capital".

Eventually:

IN PARIS, under the UNESCO, on the theme: "Actual Relationship between Sciences, Arts and philosophy.

IN BRUSSELS, with the presence of Belgium King under the Royal Academy of Sciences on "Scientific and Socioeconomic mesh"

IN LISBON, with the presence of the Republic President, under the Caloust Gulbenkian Foundation on "The Perceptions of the need of the society on innovation and satisfaction of these needs".

IN STOCKHOLM, with the cooperation of the Nobel Foundation on "The Education innovation and the transfer of exchange of knowledge between nations".

IN BUDAPEST, in the presence of the President of the Hungary Republic, S E M, Arpad Gonz, we studied "The Education against the value crisis."

IN MADRID, under the Royal Academy of Moral Sciences and Spanish politics, a workshop on "Intercultural discussion" which attracted a large crowd.

IN ZAGREB, in the presence of the President of the Croatia Republic, S E Tudjman which led a much appreciated opening speech, we have reflected on "The Cultural dimension of the scientific and technological development.

IN TRIESTE, in Italy, under the International Institute of Human Right, we have investigate bon the Ethical and juridical characteristics of the preservation of life species.

During the meeting among the requirements written to the UNESCO, we have suggested the creation of the Ethical Committee for the sciences which has been created few times later in the UNESCO framework.

Other meeting which took place in Bale (Switzerland), in Sophia (Bulgaria), in Rome (Italy), in Bucharest (Romania) ect...

Many publications were written by chosen themes.

Also the Health issues has attracted our attention during the last few years, as in 2007 we have organized in Paris an international meeting regarding "the emergent diseases".

In 2008, in Cartages in Tunisia, another conference regarding "The Health and Environment in the Mediterranean Basin".

In 2009 in Wroclaw in Poland, we reflect on the theme "Optimal Infrastructure for stimulation of scientific research in Europe.

From the prehistory to the contemporary period, human's innovations have succeeded each other at an ever increasing speed.

Ever increasing and imperious, the energizing need of the Humanity forced the scientific to endlessly research in terms of innovations.

During the last century a succession of innovation has strengthen to an extent that Man could not stop to research ... and to discover...

The Academy has established via the State Member of the UNESCO, a group of important philosophers working towards the economical and social progress of the Humanity.

Confronted to a increasing population and aware of the importance of the Health issues in the world, in 1997, the Academy created a group of experts on the theme "Fundamental Sciences and arising pathogenic factors" for which an important conference took place in Bale.

These few examples demonstrate the role that plays the European Academy side to the World Health Organization {OMS} of the FAO, thanks to a group of high skilled international experts.

The Academy which celebrates in 2010 its 30 years is dedicated to a society which must control its rhythms and must avoid the oscillation excess according the theory of incidents predicted by Thom who received the Fields Medal in 1958.

It was normal that "the scientific and ethical issues brought by the technological progress" were discussed. A conference was organized on these themes at the Polish Scientific Centre in Paris.

Thanks to the imperious collaboration of the Ambassador WU Jianmin, Vice president of the European Academy, from the president Jiang, of the Academy of science of Beijing, from Sir the Health Minister, the professor CHEN Zhu of the Academy of science in China, from the Shanghai City Authorities and other Chinese personality, for the occasion of the 30 years of the European Academy we are delighted that this new conference (for which join many Laureates of the Nobel Price, of the European Academy) able to develop in Shanghai under the Universal Exhibition (in 2010);

A very common subject: "The city and the public health", it cannot be discussed that nowadays, the biggest cities bring benefit however they lead to risks which can be major to the all humanity.

I, wish in a general manner that the conference will able to direct you towards the wellbeing of the Man and also that the environment rights should be respected as well as the right to health.

Let us highlight that the definition of the Health World Organization states:

"Health is the absence of diseases as well as an all physical and psychological well being "
